# 2025 RMG Annual Delegate Conference

THE FIRST RMG ADC to be held at Prospect's new Rochester Row HQ took place on 20 February 2025. David Harding chaired it to conclude his five-year term as Group President. Andrew Ruffhead was elected unopposed as the new Group President and Tom James was elected unopposed as the new Group Vice-President, Fran Butler was elected to serve a full term on the Group's Standing Orders Committee. It was left to the National Committee (NC) to appoint a short-term SOC member caused by a premature resignation.

Health problems made it necessary for two members of the SOC to attend remotely. This facility was extended to some observers and NC

emergencies occur. One allows an Area Meeting to elect a Representative and/or Deputy Rep if the post is unfilled during the year. The other allows the Group Secretary to invite an observer to the ADC if that member's Area has neither an ADC Delegate nor a Representative on the NC. Such an observer would have to give the Area a conference report to qualify for expenses.

#### **Pensions**

Resolution 22 from Scotland South instructed the NC to support the "68 is too late"

campaign, opposing any further rises in the state pension age. Resolution 23 from Central Southern instructed the NC to pursue Prospect's continued commitment to no means testing of State Pension Benefits.

### More on pensions

Resolution 25 from Scotland South criticised poor service levels from MyCSP who administer Civil Service Pensions. The NC subsequently collected data from members affected, and compiled a report for Prospect. Resolution 26 from North East called for members of the British Coal Staff Superannuation Scheme (some of them in Prospect) to be treated the same as members of the Mineworkers' Pension Scheme. **Emergency Resolution 1** from South West Midlands expressed concern about possible access to pension funds by the Government for investment purposes. The NC was instructed to engage with the NEC to pursue appropriate safeguards.

### Money matters

Composite Resolution 20 from the National Committee & Northern Ireland wanted the NC to press the NEC to

campaign for it to be illegal to refuse to accept Sterling cash in payment for transactions & services. Resolution 29 from East Anglia instructed the NC to press the NEC to try and persuade the Government to reverse the means-testing of the Winter Fuel Allowance.

#### **Organisation matters**

Resolution 5 from South West Midlands called for improved management and availability of RMG Rules. Resolution 13 from East Midlands instructed the NC to persuade the NEC that the Prospect website needs a direct link addressing asbestos issues within the Health-and-Safety-at-Work section. Resolution 28 from Southern instructed the NC to give Area Reps/Secretaries the opportunity to check future editions of the Autumn "Round Up" before they are sent to Retired Members.

### **Respect for pensioners**

Resolution 31 from Central Southern expressed anger at the Labour Government's attitude to UK pensioners. It instructed the NEC to try and persuade the NEC to get the TUC to arrange a protest march in support of pensioners.

### Treatment of Retired Members at Conference

Resolution 4 from London Central urged the NC to prepare a rule-change motion to improve the scope of the RMG's card vote for the 2026 National Conference. Resolution 7 from East Midlands called for "any form of ageism" to be added to National Conference warnings about unacceptable behaviour. Resolution 8 from Thames Valley called for a bar on "next business" being moved on rule-change motions, both at National Conferences and at RMG ADCs.

#### Awareness of the RMG

Composite Resolution 11 from CMMDN & South East England acknowledged the need to inform Working Members about the work of the RMG. The NC was instructed to arrange for an RMG stall at future Prospect National Conferences. See p3 'Participation-stimulation'.

# Thinking of returning to work?



THE DIFFERENCE between subscriptions for Working Members and Retired Members reflects the fact that the latter don't qualify for union help over employment issues. If you are a Retired Member who returns to the world of employment, you should notify Prospect so that you can pay the subscription based on your salary. If you have taken out a life subscription as a Retired Member, that will resume when you become a Retired Member once again.

What about Retired Members doing temporary jobs? They can opt to remain Retired Members, but if they do so they will forego union help with employment problems. The subscription rate for Working Members is modest where remuneration is low.

### **National Pensioners** Convention under threat

THE RMG pursues many pensioner issues through its affiliation to the National Pensioners Convention. The Government retreat on Winter Fuel Payments was partially due to NPC pressure. The NPC's work is important but cannot be taken for granted. Financial difficulties have forced the NPC to become a Company Limited by

Guarantee. That will at least enable the NPC to meet redundancy-pay obligations in the event of insolvency. However, much more needs to be done to enable it to apply for desperatelyneeded grants. There are also worrying delays in expected income which could affect cash flow in the next few months.
